Gold Star Affiliate – Corporate Level

- New Affiliate Set Up Fee \$500 (Includes 1st Year of Dues)
- \$300 Annual Renewal (Due January 1st)
- The corporation may designate one person to represent them.
- Designated persons would be the voting member on ECAR issues.
- Designee qualified to run for Affiliate Director on ECAR Board of Directors as a Company, not individual. Nominee must have been an ECAR Member for minimum of 2 years.
- Able to apply for access with ECAR for Supra key access, if needed to perform their everyday business, for use solely under company use only. Key to be assigned to one member only once application is approved.
- Affiliate's contact information will be provided to membership and members will be encouraged to us Affiliate Members for services when possible.
- ECAR provide a list of membership names / contact information to Affiliate.
- Encouraged to Attend, invite guests and host Monthly Membership Meetings.
